

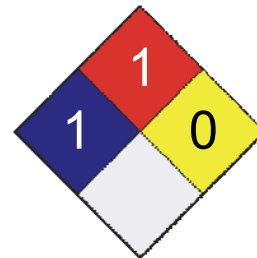

**Emergency overview** Contact may cause eye and skin irritation.
